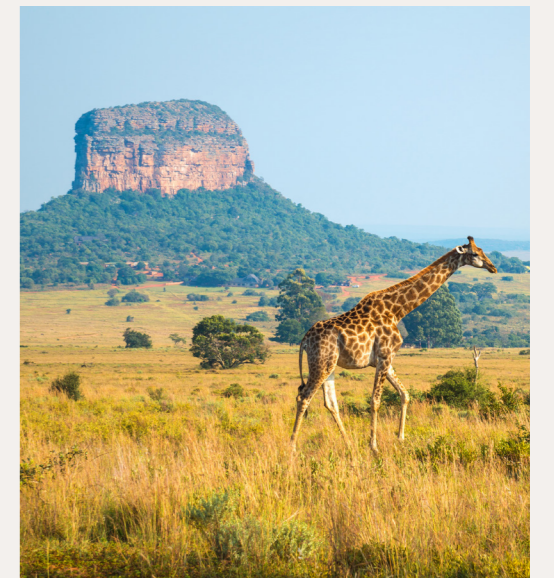
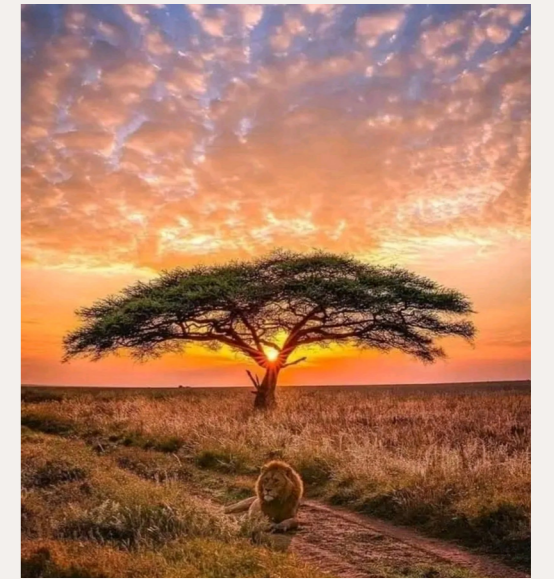


## Kruger National Park, *Limpopo and Mpumalanga*

## Domestic vs. international buyer trends

### Domestic buyers

The emerging work-from-home lifestyle is a major factor contributing to semigration to coastal areas, making these prime locations for property investment. This has led to a higher demand for properties in remote, scenic areas as home buyers seek more comfortable environments to live, work and play. With many South Africans relocating to coastal cities and towns, destinations like Langebaan, Hermanus, Plettenberg Bay, and St. Francis Bay have experienced an influx of buyers.

### International buyers

Proven to be a solid investment, foreign investors are attracted to South Africa's luxury property market, especially in Cape Town. The city was ranked fifth on Savills' World Cities Prime Residential Index, making it the only African city on the list. Prime properties in upmarket areas of Cape Town are relatively affordable compared to other global destinations. Mixed-use developments in bustling city areas are also popular, with properties providing facilities such as gyms, office spaces, and cafes on site. These are often within easy reach of shopping malls and vibrant entertainment venues.

## High-growth regions and emerging hotspots

### Western Cape

The Cape Town metropolitan area and exclusive neighbourhoods along the Atlantic Seaboard continue to attract significant interest. Blouberg, a seaside region just north of Cape Town, is fast emerging as one of South Africa's premier semigration hotspots.

### Eastern Cape

Offering some of the most sought-after real estate, particularly for those seeking a tranquil beachside lifestyle, the province has seen a surge in holiday home purchases, overtaking the Western Cape as the region with the highest volume of applications for such properties.

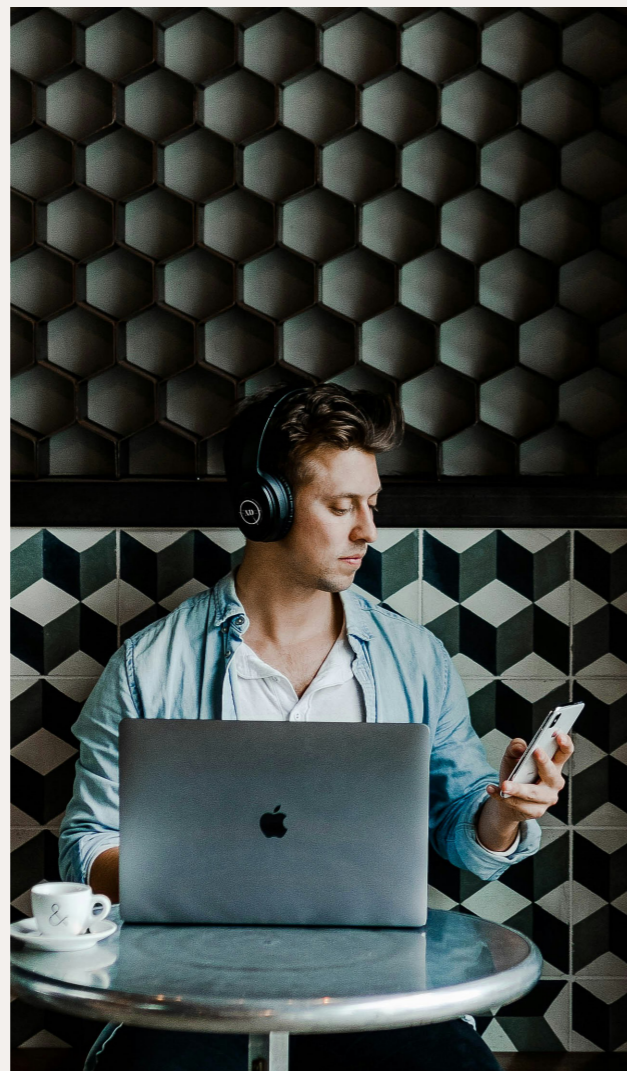

Competitive lending from banks and favourable interest rates have created more opportunities for buyers. The real estate market is projected to grow by 2.92% between 2025 and 2029, resulting in a market volume of approximately US\$1.38 trillion by 2029.

## Business and work

The country's rich cultural heritage and natural beauty make tourism a vital industry, attracting millions of visitors annually. South Africa is positioned as a key global hub and an attractive gateway into the rest of the continent. The country is not only a resource rich economy with access to both a vibrant local market and a growing regional market but also a financial, technical and innovation hub. Historically, mining has been a cornerstone of South Africa's economy, contributing significantly to GDP and employment. South Africa has a number of world-class universities, producing a skilled, talented, and capable workforce. A standard working week in South Africa is around 40 - 45 hours. Typically working hours are 8 am - 4 pm or 9 am - 5 pm, however with many dual working families, flexi-time is often an option. Remote and work-from-home models for a couple of days per week have also been implemented.



## Education

In South Africa, children between the ages of 7 and 15 are required to attend school. School times are usually between 8 am and 3 pm, with sport and extra mural activities commencing thereafter. The year runs from January to December, with two longer and two shorter holidays. Learners and parents enjoy a lively sport culture with inter-school matches played on a Saturday morning. South Africa's education system comprises public schools funded by the

government and private schools funded through tuition fees. There are 56 International schools around South Africa offering all levels of examinations including IGCSE, AS, and A-Level, catering to expatriate communities and locals seeking global education standards. South Africa's higher education institutions include world-renowned universities, higher education colleges, and university colleges.



## Cuisine

Today, South Africa's culinary landscape is a vibrant mix of innovation, tradition, and excellence. The local cuisine is a mouth-watering blend of cultural influences, from Dutch and German to Indonesian, resulting in European-style cooking made with eastern spices and flavours. Some of the country's home grown chefs who have garnered international acclaim for their innovative approaches and contributions to the culinary arts include avant-garde chef, Luke Dale-Roberts, Jan-Hendrik van der Westhuizen, the first Michelin starred South African chef, and the inspirational Kobus Van der Merwe, whose culinary delights are made with ingredients foraged along the wild Atlantic shoreline. South Africa's wine regions, particularly the internationally renowned Cape Winelands, are acclaimed for their exceptional wines and vibrant food festivals. Award-winning estates participate in wine tastings, and host gourmet dining experiences. The best-known wine regions include Constantia, Stellenbosch, Franschhoek, Paarl, and the Elgin wine route.



## Healthcare

South Africa is known for having some of the best hospitals and medical infrastructure in southern Africa. The country has a dual healthcare system: a public system managed by the Department of Health and a private system operated by private providers and funded through medical aid schemes, which is similar to health insurance. These schemes offer higher quality care and shorter wait times. The majority of the population relies on the public system for care. Although the government subsidises this care, patients often have to cover some costs themselves. Around 20% of the population opts for private healthcare, which offers high quality care with access to world-renowned specialists, private hospitals and state-of-the-art facilities. The government is also working towards implementing the National Health Insurance (NHI) to provide universal health coverage.

## Transport

South Africa's roadways vary from multi-lane highways connecting key cities to scenic routes winding through picturesque landscapes. The three major airports - namely, OR Tambo International Airport in Johannesburg, Cape Town International Airport in the Mother City and King Shaka International Airport in Durban, facilitate both domestic and international travel. Long-distance trains offer a unique journey, boasting some of the most scenic rail routes in the world. The iconic Blue Train, as well as the luxurious Shongololo Express and Rovos Rail offer the most extravagant experiences while highlighting the country's diverse landscapes and rich cultural heritage.

## Art and entertainment

South Africa is famous for its music and dance, with genres like classical, jazz, hip-hop, and traditional African rhythms shaping the country's music scene. The county is home to 'the father of jazz,' the legendary Hugh Masekela, as well as acclaimed playwrights and actors Athol Fugard and John Kani. The country's art scene is equally diverse, with influences from African, European, and Asian traditions reflected in paintings, sculptures, and ceramics. From the earliest rock art of the San Bushmen's cave paintings to the latest exhibits in the Zeitz Museum of Contemporary Art, the country's history of art is a long and interesting one. ## Head for the great outdoors

With a fantastic climate and diverse landscapes, South Africa has an enthusiastic sport and outdoor culture. From bungee jumping in the Eastern Cape, or hot air ballooning over the Magaliesberg mountains to shark cage diving in Cape Town, you are spoilt for choice. The coastlines along the Atlantic and Indian Oceans are prime surfing spots. Along with Muizenberg in Cape Town and Durban's Golden Mile, Jeffrey's Bay in the Eastern Cape is internationally acclaimed for its surfing breaks. Other big features include internationally renowned mountain biking events such as the Cape Epic, and prestigious marathons like the Comrades and Two Oceans marathons. South Africans are passionate about rugby and the country's national team, the Springboks is a symbol of national pride, ardently supported by their superfans.



# The buying process

South Africa's strong real estate market and favourable exchange rates make buying property very appealing for foreigners. However, non-residents keen to invest in property in this magnificent country are subject to certain conditions and procedures. South Africa does not currently offer a golden visa or citizenship by investment programme.

Here's a detailed guide to the process:

## 01. ELIGIBILITY

Foreign nationals can acquire and own property in South Africa without restrictions, except for undocumented immigrants who are prohibited from owning immovable property. Owning property does not automatically grant residency status. Foreigners need to obtain the appropriate visa, work permit, or residence permit to live in South Africa.

## 02. FINANCING THE PURCHASE

Foreign buyers can obtain mortgage financing from South African banks, generally requiring a deposit of at least 50% of the property's purchase price. Alternatively, purchasing property with cash is permissible.

## 03. TAX IMPLICATIONS

Transfer Duty is a tax imposed on all property transactions, calculated based on the purchase price or market value, whichever is higher. When selling a property, the profits from the sale are subject to Capital Gains Tax (CGT).

## 04. EXCHANGE CONTROL REGULATIONS

When transferring funds for property purchase, compliance with South Africa's exchange control regulations is required. All foreign currency transactions should be processed through an authorised dealer, which is typically a South African commercial bank authorised by the South African Reserve Bank (SARB).

## 05. PURCHASE PROCESS

Once a property has been selected, an Offer to Purchase (OTP) must be signed by both the buyer and the seller. On acceptance it becomes a contract of sale with the document outlining specific terms and conditions. In South Africa, a conveyancer (property attorney) is required to manage the transfer of ownership, ensuring all legal requirements are met. The Deeds Office will then officially register the property in the buyer's name. This process typically takes 8 to 12 weeks from the date of signing the Offer to Purchase.

## 06. DOCUMENTATION AND FICA COMPLIANCE

Simultaneously with signing the Offer to Purchase (OTP), all buyers, including foreign buyers, are required to comply with South Africa's Financial Intelligence Centre Act (FICA) regulations. This is a crucial process that ensures transparency in property transactions by verifying the beneficial ownership and the legitimacy of the funds being used. This includes a valid passport as proof of identity, proof of residence and documentation proving the source of funds for the purchase would be required.

# Ways to own property in South Africa

Foreigner buyers can purchase property through various means, including direct ownership, through a local company, or through a trust. It's crucial to have a South African lawyer review the sale agreement and ensure compliance with exchange control regulations.

## 3 Ways to buy

### 1. Direct ownership

Foreigners can buy and own property in their own names, as well as arrange finance through a South African bank, though the terms may be different for non-residents as they may be required to bring in foreign currency to fund the purchase.



### 2. Through a local company

Property can be bought through a South African company, registered as an "External Company" with the Companies and Intellectual Property Commission (CIPC). When owning through a company, funds brought into South Africa will be treated as a loan to the local entity, requiring exchange control approval.

### 3. Through a trust

Another means of owning property is via a South African trust. A foreign trust needs to be registered with the Master of the High Court before land can be registered in the trust's name. Funds brought into the country will be considered a loan to the trust, also requiring exchange control approval.
